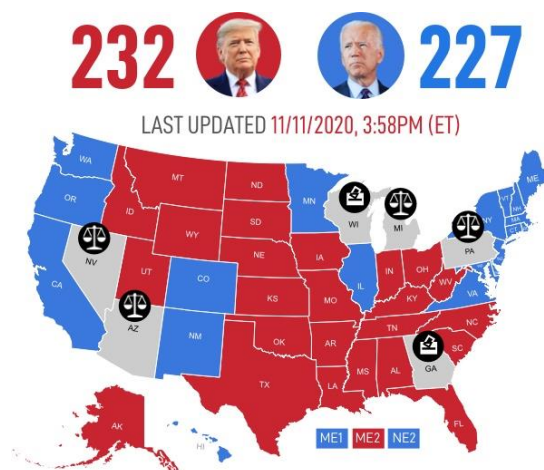
# President's Message
